The Mayflower Council will send numerous contingent troops to the 2026 National Jamboree at the Summit.

Scouting's flagship national event is one-of-a-kind. It's a

gathering of tens of thousands of Scouts and Scouters showcasing everything that is great about Scouting. Over the course of 10 summer days scouts join together for this iconic outing. Because it normally takes place every 3 to 4 years, most Scouts will only have one opportunity to visit the Jamboree as a youth. Many Jamboree Alumni said their experience was one of the most memorable adventures during their years in Scouting.

WHEN IS THE NATIONAL JAMBOREE:

The 2026 National Jamboree will take place July 22 - 31, 2026. The contingent will leave a few days before and return after the last night of the jamboree.

WHAT IS THE NATIONAL JAMBOREE:

It's the most awesome event a Scout or Venturer could attend. It's everything you can do in Scouting—and more—in one spot just for you . . . and about 25,000 of your friends from around the country and around the world! It's 10 days of adventure and excitement that you don't want to miss!!

WHERE IS THE JAMBOREE?:

The Summit Bechtel Reserve is home to the National Scout Jamboree. Situated in the wilds of West Virginia, The Summit is a training, Scouting, and adventure center for the millions of youth and adults involved in the Boy Scouts of America and anyone who loves the outdoors. The CFC contingent will travel to the Summit in chartered motor coaches accompanied by trained and experienced adult scout leaders. The Summit is a place that takes Scouts and Venturers to the limits of what they think they can do, and then pushes them further.

ARE THERE QUALIFICATIONS?:

Jamboree Qualifications: Scouts BSA, Ventures, Sea Scouts and Explorers MUST have a current BSA membership, be at least a First Class Scout.(or equivalent depending on program) MUST be at least 12 years of age by the first day of the Jamboree but have not reached their 18th birthday by the last day of the Jamboree. Be approved by their home unit leader and local council. MUST have appropriate parent/guardian to complete the online parental consent. (An email will be sent to the parent/guardian during the application process.) Participate in mandatory pre-Jamboree training experiences with local council and Jamboree unit leadership. Submitted BSA Annual Health & Medical Record using the on-line Jamboree submission process.

WHAT'S THE COST?:

- Early Bird Rate: Youth if deposit made by May 1, 2025: \$3,450
- Youth after May 1, 2025 to October 1 \$3,600
- Youth after October 1, 2025 \$3,840
- Early Bird Rate: Adult leaders if deposit made by May 1, 2015: \$3,100
- Adult after May 1, 2025 to October 1 \$3,250
- Adult after October 1, 2025 \$3,490

Mayflower Council Fee Update

We're committed to providing the best Scouting experience possible for all youth in the Mayflower Council. After careful consideration, the Mayflower Council Executive Board has approved an increase in the annual program fee, effective August 1, 2024. This increase was originally announced on

March 27, 2024.

What's Changing:

- The program fee will increase from \$48 to \$68 per youth member in Cub Scouting, Scouts BSA, Venturing, and Exploring.
- This fee does not apply to adult members.

2024 Annual Membership Fee Update - New Dates

Update on National Fees:

- The new registration fee structure of \$85 per youth & \$65 per adult will be effective on May 1, NOT April 1.
- The elimination of the new member \$25 joining fee will

still be effective April 1.

Effective April 1, 2024, the BSA will eliminate the \$25 onetime joining fee for new program participants in Cub Scouts, Scouts BSA, Venturing and Sea Scouting.

Effective May 1, 2024 (formerly April 1), registration fees will be as follows:

- **\$85/yr** for Cub Scouts, Scouts BSA, Venturing and Sea Scouting participants (\$5 increase)
- **\$65/yr** for all adult volunteers (\$5 increase)
- \$30/yr for Scoutreach (No change in fee)
- **\$25/yr** for Merit Badge Counselors (No change in fee. Only for Merit Badge Counselors not already registered as leaders)
- **\$50/yr** for Exploring participants Youth & Adult (No change in fee)
- \$100/yr unit renewal/affiliation fee (No change in fee)
- \$15/yr for Scout Life magazine (No change in fee)
- Council Program Fee will remain at \$48 for Cub Scouts, Scouts BSA, Venturing and Sea Scouting participants until July 31, 2024 and then will increase to \$68 on August 1, 2024

CORI and SORI Forms For Summer Camp

Requirements for Leaders, Volunteers and Staff Members Attending or Working at Summer Camp

Camp Resolute and Camp Squanto places the greatest importance on creating the most secure environment possible for our youth campers.

We are required by the Commonwealth of Massachusetts Department of Public Health regulations to obtain a CORI (Criminal Offender Registry Information) and a SORI (Sex Offender Record Information) check on all adult leaders, volunteers attending camp with your troop and camp staff.

Any adult leader or volunteer who will be providing leadership while they are in camp must have a completed CORI and SORI form on file with the camp regardless of the amount of time they are in camp.

CORI Request

The CORI request for for summer camp is different than the CORI request form you filled out to be a volunteer with the

Mayflower Council. Massachusetts camps are required to perform a CORI check that will result in the camp receiving all conviction, non-conviction and pending information in both the adult record (age 17 and older) and juvenile data. As this is a different CORI check being completed a different CORI form than the one you filled out to volunteer in Scouting is required.

The CORI regulations require that each leader, volunteer or staff member provide a government issued photo identification such as a driver's license, passport, state identification, etc... and that a copy of the ID be kept on file with the camp.

SORI Request

Camp Resolute and Camp Squanto is also mandated by Commonwealth of Massachusetts Department of Public Health to obtain a Sex Offender Registry Information (SORI) report from the Massachusetts Sex Offender Registry Board (SORB) for all camp staff or volunteers. The Sex Offender Registry Board is a public safety agency responsible for protecting the public from sex offenders.

District Leadership Structure

Changes Coming

Over the past year, a great deal of discussion has ensued regarding the district leadership structure of Mayflower Council. It has become increasingly challenging to fill the many district committee positions and ensure that the support needed for the Scouting program is being provided in the most efficient, effective, and consistent manner.

A committee was formed last summer of individuals from across the council to determine the best path moving forward given the current number of unfilled positions. A wide variety of options were considered and discussed at length; it was decided that to best way to provide a quality scouting program in Mayflower Council was to adopt a more Council centralized support structure in place of what has previously been a District-centered approach. It is extremely important to note that the continued involvement of current leaders, and recruitment of others, will be a critical element as we move forward. The knowledge base and dedication of the current corps of volunteers will be integral to the new leadership structure.

To facilitate a smooth transition to this type of structural leadership change, an Implementation Team has been identified to collect information and identify "next steps" for the transition. It is anticipated that the roll out will occur in a stepwise fashion during the 2024-25 program year. In the coming months there will be in-depth discussions amongst various committees and constituents to solicit input and help the Implementation Team develop a well-defined roll out plan. This will be an evolving process, with information to be provided as it becomes available. The Implementation Team is planning to hold a Council-wide Summit in October, open to those currently serving in District leadership positions and all others who are interested.

Every effort will be made to ensure responses are sent as quickly as possible, recognizing that answers to many questions may not be available until the roll out plan is better defined.
